

Draft Minutes – ACA Board Meeting, September 23, 2008

- I. Minutes from July 2008 Board meeting approved
- II. Presentation – Tour of Colorado, by Andy Bohlman
 - a. He has acquired trade name and domain rights to Tour of Colorado
 - b. After speaking with the Governor’s representative on tourism, the idea of running a tour, on the scale of Tour of Georgia, was well received (but no funding is available)
 - c. Current concept is to run series of individual races under the banner of the Tour of Colorado
 - d. More information to follow
- III. Report – Promoters’ Meeting, (Jon Tarkington)
 - a. Topics included: number of races, safety concerns, race calendar, BAR/BAT, race kit, length of race day
 - b. Some promoters were hit hard by poor attendance – some for weather-related reasons, others for calendaring reasons (e.g., day after Bob Cook).
 - c. Discussion of ideas to mitigate the financial hardship caused by poor weather
- IV. Legislative Update (Jon Tarkington)
 - a. Issue – listing of clubs on results; should non-ACA clubs be recognized? Or should rider belonging to clubs not affiliated with ACA simply be designated as “unaffiliated”
 - i. On the one hand: ACA affiliated clubs are required to promote/support at least one race per year; other clubs

are not. More support for racing is better. Additionally, for ease of data entry, clubs not affiliated with ACA have to be entered manually

- ii. On the other hand: even clubs not affiliated with ACA may support racing. Sponsors of such clubs may balk at their clubs going unrecognized (possible solution – join the ACA?)
 - iii. Possible compromise: riders who belong to clubs not affiliated with ACA pay surcharge for ACA license
- b. Issue – upgrades from one category to the next (sandbagging)
- i. Problem: racers who deliberately avoid upgrading from one season to the next
 - ii. Discussion: empower the District Representative (Yvonne) to declare upgrades
 - iii. No action taken
